Tuition and Fee Schedule for 2010 - 2011

(Tuition will only be pro-rated after October 15th to appropriately reflect the reduced time frame for a late start enrollment.)

We are pleased to again offer a 4% discount to parents who want to take advantage of the convenience of paying for their total tuition with a single payment.

If you elect to take Plan A, Half-Day or Full-Day, the Registration Fee of \$795 or \$1,050 is deducted from your total amount due and this amount must be paid in full before your child can begin attending.

If you elect to go with Plan B, your Registration Fee will be applied to your last monthly payment. Before your child begins attending, payment for the first month or part thereof must be submitted.

Before and after school Day Care

Should you need your child to stay at school after class time ends, we have several options available so that, if selected at the time you sign the Enrollment Agreement, you will save more than 50% on the cost of Day Care coverage over what it will cost if it is needed at a later date, or on a Drop-In basis.

Benefits of selecting Day Care at the time of signing the Agreement include:

- 1) Day Care till 5pm on all but two of the five Minimum Days (the school will close at noon on Dec.17 & June 10).
- 2) Day Care on each of the four Parent/Teacher Conference days
- 3) A 4% discount on the Day Care rates for Plan A Prepaid Day Care packages

Toddler Day Care will only be available if 4 or more Toddlers have paid in advance for Day Care to 4:00 pm

Morning Care is a Separate Package

Morning Care - Drop off between 7:30 and 8:10 am - Total for Sept. - June - **\$445**

Pre-paid Drop-In Day Care, when classes begin, is \$10 per hour.
Drop-In Day Care, if not pre-paid, is \$15 per hour.

Please include the \$350 Enrollment Processing Fee when you submit the Enrollment Application.

NOTE: A non-refundable Registration Fee of \$795 (Half-Day) or \$1,050 (Full-Day) must be submitted with your completed and signed Enrollment Agreement.

Families choosing to make monthly payments are required to make those payments using our Electronic Funds Transfer (EFT) payment processing system.

Purchasing the Dewar Tuition Insurance Refund Plan is mandatory for all families who choose to make monthly payments (Plan B).
